

BROOKS BEST FEST SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Brooks Best Fest Sweepstakes (“Sweepstakes”) is sponsored by Brooks Sports, Inc. (“Sponsor”), 3400 Stone Way N., 5th Floor, Seattle, WA 98103, USA and is administered by Prize Logic, LLC, (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033, USA.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on August 12, 2019 at 12:00 PM Eastern Time (“ET”) and ends on September 22, 2019 at 11:59:59 PM ET (“Sweepstakes Period”). The Sweepstakes Period includes six (6) drawing periods as set forth in the charts below:

All non-winning entries from each drawing period will carry forward into subsequent drawing periods. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia), who are at least eighteen (18) years old, or the age of majority, whichever is older, at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

3. **HOW TO ENTER:** During the Sweepstakes Period an eligible entrant may receive Sweepstakes entries through the following methods of entry:

Boxes will be allowed), city, state, zip code, selecting male or female, and selecting his/her shoe size. Entrant will then be prompted to take the Brooks Running Pledge by clicking the “Pledge” box. Upon the successful submission of the registration information, and taking the “Pledge”, entrant will receive one (1) entry into the Sweepstakes. There is a limit of one (1) entry through this method during the entire Sweepstakes Period.
 - b. **Share a Video or Photo:** An eligible entrant may submit a video or photo sharing a personal celebration on (i) the Website, (ii) Twitter, and/or (iii) Instagram. To submit a video or photo on the Website, an eligible entrant may follow the steps set forth on the Website. To submit a video or photo on Twitter or Instagram, an entrant must log on to his/her Twitter or Instagram Account, upload the video or photo showing his/her personal performance record along with @brooksrunning and the hashtag #BrooksBestFestSweeps (collectively, the “Entry”).

By entering the Sweepstakes and using the appropriate hashtag, entrant hereby agrees to be bound by these Official Rules. An entrant must have a non-private Twitter account or Instagram account to enter the Sweepstakes using Twitter or Instagram and must be a follower of @brooksrunning on the platform used for 60 days after the end of the Sweepstakes Period for winner notification purposes to be eligible to win/claim a prize. If an entrant does not have a non-private Twitter account, he/she can create one at no cost by visiting www.twitter.com. Please note that an entrant must agree to comply with the Twitter Terms of Service (<https://twitter.com/tos/>) and Privacy Policy (<https://twitter.com/privacy>) (if entering using Twitter) in order to participate in the Sweepstakes. Entrants may create an Instagram account at no cost by logging on to <http://instagram.com>. Creation of an Instagram account requires a contestant to agree to Instagram’s Terms of Service and Privacy Policy, available at <http://instagram.com/about/legal/terms/> and <http://instagram.com/about/legal/privacy/>, respectively. Due to the way Instagram operate its services, entries from users with protected or private accounts (i.e., entrant has set his/her account so that only people the entrant has approved can view his or her updates) may not be received. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Instagram or Twitter. Each entrant specifically agrees to release Instagram/Twitter from any and all liability associated with this Sweepstakes. Entries will be deemed made by the authorized account holder of the account the Entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Instagram/Twitter account by the online service provider.

Once an entry is submitted in the Sweepstakes it may be made available on Sponsor’s social media accounts or other websites for viewing by the general public and any such posting will be deemed made at the direction of the entrant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act.

- Entry must comply with the respective social media platform terms;
- Entry cannot have been published previously by any party other than the entrant;

- Entry cannot prominently feature trademarks, logos or trade dress owned by any third party, or advertise or promote any brand or product of any kind, other than the Sponsor's;
- Entry cannot contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art or images);
- Entry cannot include the name, likeness, photograph, or other indicia identifying any person, living or dead, without written permission from that person;
- Entry cannot be sexually explicit or suggestive, violent or derogatory of any ethnic, racial, gender, religious, professional or age group;

If an entrant enters more than one (1) time per platform per day, only the first Entry will be included in the Sweepstakes. For purposes of this Sweepstakes, a day is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET except on August 12, 2019 when a day will begin at 12:00 PM ET.

- 4. RANDOM DRAWING:** On or around each date set forth in the chart in Section 1, the Administrator will randomly select one hundred thirty-five (135) potential winners from all eligible entries received for the applicable drawing period. There will be a total of eight hundred ten (810) potential winners during the entire Sweepstakes Period, (five hundred forty [540] potential winners from entries received on the Website, and a two hundred seventy [270] potential winners from entries received on Twitter/Instagram collectively). Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
- 5. PRIZES, APPROXIMATE RETAIL VALUES (“ARV”), AND ODDS OF WINNING:**
- A. Prizes (810):** The prize is a pair of Limited Edition Ghost 12 Shoe (each a “Prize”). No more than eight hundred ten (810) Prizes will be available in the Sweepstakes, one hundred thirty-five (135) per drawing period. The ARV of each Prize is \$130.
- B. Total ARV:** The total ARV of the prize is \$105,300.

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
